Scope and Content Note:

This collection contains the writings of two prominent New Hampshire politicians, Governor William Plumer and William Plumer Jr., from the late 18th through the mid-19th century, a time when the new nation was still forming and establishing its principles and character. The writings include correspondence, biographical and historical notes, essays and speeches, legal and financial papers, poetry, and a variety of journals, notes, and memoranda.

Biographical Background:

The information in this section is compiled from the works of Mevers, Turner, the biographical notes in the Library of Congress finding aid, the biographical notes in the New Hampshire Historical Society finding aid, and online sources. See the reference section at this end of this document.

William Plumer (June 25, 1759-December 22, 1850) was born in Newburyport, Massachusetts but moved with his family to Epping, New Hampshire in 1768. He became a Baptist preacher before studying law, was admitted to the bar in 1787, and became involved in politics. He was elected to the New Hampshire legislature (1785-1786, 1788, 1790-1791, 1797-1800), including service as Speaker of the House and President of the Senate; the U.S. Senate (1802-1807); and as governor of New Hampshire (1812-1813, 1816-1819). He was also a presidential elector.

He was an advocate for making Dartmouth College a state university, and a founder of the New Hampshire Historical Society. During his term, the construction of the New Hampshire state house was completed. He intended to write a comprehensive history of the United States and compiled a great deal of information, but eventually abandoned the project and focused instead on writing biographies of people who had been influential in the rise of the new nation

Plumer married Sarah ("Sally") Fowler in 1788 and had five children. He died in Epping at the age of 91.

William Plumer, Jr. (February 9, 1789 - September 18, 1854) was born in Epping, New Hampshire, educated at Philips Exeter Academy, and graduated from Harvard in 1809. He was admitted to the bar in 1812 and followed his father's footsteps into politics, serving in the United States House of Representatives and in the New Hampshire Senate. He also served as Justice of the Peace and United States Commissioner of Loans for the state of New Hampshire. A poet, author, and abolitionist, he gave orations and participated in debates on a wide variety of topics. He also wrote a biography of his father.

Plumer, Jr. married Margaret Frost in 1820 and had three children. He died in Epping at the age of 65.

Provenance:

The bulk of Plumer and Plumer Jr.'s written work is housed in the New Hampshire State Library. The library probably received these items as a gift from the Plumer grandchildren in the late 19th century and just at the beginning of the 20th. Plumer titles appear in NHSL's publication "Author List" in 1897, 1902, 1904, and 1908. A second donation was made to the New Hampshire Historical Society in 1886. A third set of documents was purchased by the

Library of Congress between 1906-1923. The contents of these collections is noted by Turner in his biography of Plumer (p. 349-354).

How and by whom the decision was made to divide the collection is apparently unknown. As Mevers points out (p. 2), the researcher would need to consult all three of the major repositories to compile a complete chronological sequence of the lives of William Plumer and William Plumer Jr.

Span Dates: 1786-1863, bulk 1800-1840's.

Collection Strengths:

William Plumer and his son William Plumer Jr., corresponded voluminously not only with each other but with some of the key figures in the development of the United States, including presidents, cabinet members, Congressmen, newspaper editors, social reformers, governors, cartographers and scientists, judges, military veterans, professors, and clergymen. The letters are the largest and most valuable part of the collection, containing originals as well as drafts and copies of letters sent. Some of the signatures themselves are quite valuable. The subjects written about, from the vantage point of two men who were often actively involved in the events they discuss, include the Federalist Party, Louisiana Purchase, the War of 1812, slavery, Indians, foreign relations, international trade and events, public debt, and the inner workings of Congress.

Also of interest are the biographical notes and sketches of key figures in US history and Plumer's notes on the history of the country. William Plumer Jr.'s agricultural journals throw light on the concerns of a farmer in the 19^{th} century. The collection also contains the draft of his biography of his father.

Collection Size and Condition: The papers are contained in 19 legal size archival boxes, 6 of which are half-size (2.5 inches deep), and 13 of which are full-size (5 inches deep). The 19 boxes span approx. 6.8 linear feet.

The collection was stored for many years in archival boxes and folders in a room with no temperature controls. A few documents have faded writing and some of the paper is beginning to soften. Overall however, the general quality of the documents in this collection is good.

Copyright Status and Access: The collection is owned by the New Hampshire State Library and may be viewed at the library upon request. Certain valuable documents may only be viewed and /or copied with permission of the library administrator or state librarian.

Portions of the Plumer papers had been processed previously, notably the calendar of the correspondence, prepared by Lynn W. Turner, probably in the 1960's or 1970's, and the 1982 guide to the microfilm edition of the William Plumer Papers, edited by Frank C. Mevers, Zephorene L. Stickney, and Ruth W. Wallace. Turner's calendar provides detail on each letter, including a brief annotation of the subject, as well as correspondees, date, and place. The guide to the microfilm edition provides background information on the Plumers and some of the key figures with whom they corresponded. The microfilm is not organized in the same order as the original manuscripts; this may possibly have been determined by how many frames can be contained on one microfilm reel. The order of the original manuscripts in this collection was largely retained, although the rationale for including numerous documents in one folder was not always evident. It was occasionally necessary to divide the contents of one folder into two, in order to keep documents from becoming damaged.

Identifying which documents were created by WP and which by WP Jr. was sometimes a challenge. There are several decades when it is feasible that either father or son could have written on the same subject, given their common interest in politics, the law, government, and history, and their similar involvement in public service. Distinguishing between the different handwriting of father and son is difficult and it is easy to fall into the trap of thinking that if the subject matter is associated with one William, then everything on that subject must be by the same William. This is not the case. For example, even though William Sr. worked extensively on preparation of biographies, there are several documents in the folder of biographical papers and notes signed by William Plumer, Jr. (One helpful, if not conclusive, difference in their writing is Sr.'s rounded capital A, in contrast to Jr.'s sharp and pointed capital A.)

On at least two occasions, there is a discrepancy as to the author of a document, whether William Sr. or Jr. One instance is the biographical sketches, which are noted in the NHSL author list as being the work of WP, Jr. These seem, from comparison of handwriting, to be the work of WP, Sr.

The second instance is the poem "Ruth", which has been attributed to both WP Sr. and Jr. (e.g. there is a DLC MARC record assigning authorship to WP Sr.). Given WP Jr.'s other published works of poetry and WP Sr.'s own remarks on his lack of poetical skill (Turner, p. 27), the poem was most likely written by WP Jr. Conflation of father and son also occurs in internet searches and in OCLC's MARC records and can be confusing (e.g. William Plumer's gubernatorial address of 1812 is attributed on at least 4 records to William Plumer 1789-1854 - Wm. Jr. was never governor of NH and would have been 23 years old in 1812).

The New Hampshire State Library also has numerous other works of WP and WP Jr. which have been cataloged separately from this collection. Most of these are also manuscripts but presumably were received at a different time or from a different source than the materials here cataloged. A complete list of the library's other Plumer holdings, both in print and manuscript form, is included in the Resources section at the end of this finding aid.

Arrangement and Description

This is a large and complex collection, containing works by both William Plumer (WP) and William Plumer, Jr. (WP, Jr.), and spanning several decades. The papers at the New Hampshire State Library had already been placed into folders and boxes, sorted, and labeled by category some time after they were received in the early 1900's. Papers of father and son are intermingled and, as indicated above, it is not always possible to determine the author. Apparently for this reason, materials were originally sorted by subject, rather than by author. However, several boxes contain the work of WP. Jr. only.

There are five series for this collection, arranged at either the item or the folder level, depending on type of content.
